ABOUT INDUSTRY SKILLS AUSTRALIA

Industry Skills Australia (ISA) has been appointed as the Jobs and Skills Council (JSC) for the nation's Aviation, Maritime, Transport and Logistics and Rail industries and the emerging sectors of Omnichannel Logistics and Distribution, and Air and Space Transport and Logistics.

Following reforms to Australia's vocational training system, we became the Transport and Logistics Industry Skills Council in 2005 and Industry Skills Australia (Skills Service Organisation) in 2016

Training Packages, the Australian Qualifications Framework (AQF) and competency standards

Training Packages

- specify the knowledge and skills required by individuals to perform effectively in the workplace, which are expressed in units of competency
- detail how units of competency are packaged into nationally recognised and portable qualifications that comply with the Australian Qualifications Framework (AQF)
- prescribe assessment requirements, but they do not prescribe how an individual should be trained
- specify the qualifications determined by industry groups and when required, by regulatory requirements to be most relevant for employment within the industry
- are used for a number of purposes, but they are predominantly used:
 - by RTOs, to design training curriculum tailored to support individual learner needs, and the needs of employers and industry
 - by employers, to assist with workforce design, development and structure
- are developed by the relevant national JSC in consultation with a range of stakeholders
- are recommended to Training Package Assurance Body (a body nominated by Skills Ministers), to assess draft training products against the Training Package Organising Framework (TPOF) and make recommendations to Skills Ministers about the endorsement of proposed training products
- enable nationally recognised qualifications to be awarded through direct assessment of workplace competencies
- encourage the development and delivery of flexible training to suit individual needs and industry requirements
- support learning, training and assessment in a work-related environment, leading to verifiable workplace outcomes.

The title of each endorsed Training Package is unique and relates to the broad industry coverage of the Training Package.

Each Training Package has a unique national code assigned when the Training Package is endorsed, for example AVI.

Training and assessment using Training Packages must be conducted by a Registered Training Organisation (RTO) in compliance with the relevant VET Regulator.

Australian Qualifications Framework

The Australian Qualifications Framework (AQF) provides a comprehensive, nationally consistent framework for all qualifications in post-compulsory education and training in Australia. In the Vocational Education and Training (VET) sector the AQF enables national recognition of qualifications and Statements of Attainment.

The AVI Aviation Training Package Release 12.0 provides details of the Units of Competency that must be achieved to award AQF qualifications.

The rules around which Units of Competency can be combined to make up a valid AQF qualification are referred to as the packaging rules. The packaging rules must be followed to ensure the integrity of nationally recognised qualifications issued.

The packaging rules are defined within each qualification in a Training Package.

Competency Standards

The broad concept of industry competency is the ability to perform particular tasks and duties to the standard of performance expected in the workplace. Competency standards cover all aspects of workplace performance and involve:

- performing individual tasks
- managing a range of different tasks
- responding to contingencies or breakdowns
- dealing with the responsibilities of the workplace, including working with others.

Workplace competency is the ability to apply relevant skills and knowledge consistently over time and in the required workplace situations and environments.

Competency standards are determined by industry to meet industry skill needs and focus on what is expected of a competent individual in the workplace.

Summary of the AVI Aviation Training Package

The AVI Aviation Training Package Release 12.0 comprises:

- *Twenty (20) qualifications*
- *Two hundred and eighteen (218) Units of Competency and associated assessment requirements*
- *Thirty-four (34) Skill Sets*

The AVI Aviation Training Package provides details of the Units of Competency that must be achieved to award AQF qualifications.

The title of each endorsed Training Package qualification is unique. Qualification titles use the following sequence:

- First, the qualification is identified as either Certificate I, Certificate II, Certificate III, Certificate IV, Diploma, Advanced Diploma, Graduate Certificate, or Graduate Diploma
- This is followed by the words 'in' for Certificates I to IV and Graduate Certificate, and 'of' for Diploma, Advanced Diploma and Graduate Diploma
- Then, the industry descriptor, for example Warehousing
- Then, if applicable, the occupational or functional stream in brackets, for example (Track Work).

Each training package qualification must have a unique code that complies with AVETMISS and conforms to the following:

- training package identifier—three alpha characters
- AQF level identifier—single numeric character identifying the AQF level
- sequence identifier—two numeric characters identifying the sequence of that qualification at that qualification level in the training package
- version identifier—two numeric characters identifying the year in which the qualification was approved for implementation. For example: AVI20118 Certificate II in Transport Security Protection

Units of Competency

Codes and titles

Units of Competency are nationally agreed statements about the skills and knowledge required for effective performance in the workplace. They outline work outcomes as defined by regulatory requirements and agreed by industry.

As such, they identify the skills and knowledge (as outcomes) that contribute to the whole job function - they do not describe how to perform a particular role.

Each Unit of Competency covers a specific work activity, the range of conditions under which the activity is conducted and the foundation skills essential to performance.

There are mandatory conventions specified in the Standards for Training Packages for the titles and codes used in Training Packages and their components.

The codes are assigned to Units of Competency when the Training Package is endorsed, or when new Units of Competency are added to an existing endorsed Training Package.

Each Unit of Competency has a specific character code where the:

- First three characters identify the Training Package, *for example: AVI*
- Next character/s indicates the competency field
- Numbers identify a unit's position in the sequence of the Unit of Competency field in the Training Package.

For example: AVIE0001 Operate aeronautical radio

Not for Public Access (NFPA)

The Not for Public Access (NFPA) classification should be used when the compromise of the confidentiality of information could be expected to cause limited damage to the national interest, organisations or individuals through impacts on national security, agency operations or industry sector operations.

Regulation and licensing implications for implementation

People employed in the aviation industry need to fulfil competency and training requirements as detailed in the regulations relevant to their job role. People assessed as complying with these requirements are usually provided with some form of certification by the Civil Aviation Safety Authority (CASA) or other relevant bodies.

These are certificates required by the relevant state/territory or Australian legislation or international code or convention before a person can be allowed to work in the job role covered under the legislation. These certificates should not be confused with national educational qualifications that are issued by RTOs. While in the aviation industry there is a close relationship between the regulatory certificates and the national VET qualifications, they are issued by different organisations under different legislative authorities.

Individuals seeking accreditation as a Transport Security Screening Officer should check industry- specific accreditation requirements with the Aviation and Maritime Security Division of the Department of Home Affairs.

Individuals seeking certification or licensing outcomes for specific job roles should confirm regulatory requirements with the relevant Australian Government agency for the following occupational areas:

Qualifications Entry Requirements

Entry requirements are the knowledge, skills or experience required to enter a qualification. They may be expressed as Units of Competency, qualifications or vocational outcomes and **must** be demonstrated prior to commencing the qualification.

In the AVI Aviation Training Package the following entry requirements apply:

- Entry requirements are the knowledge, skills or experience required to enter a qualification. They may be expressed as Units of Competency, qualifications or vocational experience and must be achieved or demonstrated prior to commencing the qualification.
- In the Aviation industry there are some restrictions on regulatory and licensing components that may be relevant to some job roles detailed in a qualification, Unit of Competency or Skill Set.

For the AVI20325 Certificate II in Transport Security Protection:

- Individuals undertaking this qualification must have passed a valid background check prior to accessing security-restricted resources associated with AVIG0006 Work effectively in a transport security environment. A valid background check for the purposes of an individual undertaking the qualification is a background check on an applicant for, or the holder of an aviation security identification card or maritime security identification card.

For the AVI40422 Certificate IV in Aviation (Remote Pilot-Beyond Visual Line of Sight):

- individuals undertaking this qualification must have the AVI30419 Certificate III in Aviation (Remote Pilot) or equivalent. This qualification was replaced by AVI30426 Certificate III in Aviation Remote Piloting in AVI Aviation Training Package Release 12.0.
- alignment to Remote Pilot Licensing requirements described in Civil Aviation Safety Regulation (CASR) Part 101 — Unmanned aircraft and rockets and Part 101 Manual of Standards.

For the AVI50115 Diploma of Aviation (Air Traffic Control):

- entrants must possess the minimum entry requirements determined by CASA for air traffic services licensing purposes or Defence Air Traffic Controller entry standards.
- alignment is to the CASR Part 65 Manual of Standards (MOS) air traffic services licensing requirements; personnel seeking certification as an Air Traffic Controller are to apply to CASA in accordance with existent licensing procedures.

For the AVI50222 Diploma of Aviation (Commercial Pilot Licence – Aeroplane)

- commercial or military pilot entrants to this qualification should check requirements with CASA or Defence Aviation for specific pilot entry standards.

For the AVI50322 Diploma of Aviation (Commercial Pilot Licence – Helicopter)

- commercial or military pilot entrants to this qualification should check requirements with CASA or Defence Aviation for specific pilot entry standards.

For the AVI50519 Diploma of Aviation (Instrument Rating):

- commercial or military pilot entrants to this qualification should check requirements with CASA or Defence Aviation for certification and/or flight hour requirements.

For the AVI50426 Diploma of Aviation Flight Instructor:

- commercial or military pilot entrants to this qualification should check requirements with CASA or Defence Aviation for certification and/or flight hour requirements or be able to demonstrate equivalent competence.

For the AVI60219 Advanced Diploma of Aviation (Pilot in Command):

- commercial or military pilot entrants to this qualification should check requirements with CASA or Defence Aviation for certification and/or flight hour requirements or be able to demonstrate equivalent competence.

Access and Equity

Best practice in training and assessment include making adjustments to meet the learning and assessment needs of individuals. An open mind, common sense and tailoring training and assessment to individual circumstances should ensure individuals achieve the standards employers and RTOs expect.

Adjustments can be made to assist learners to access and participate in VET. Adjustments are reasonable if they achieve this purpose and take into account factors, such as the nature of the learner's ability and disability, the views of the learner, the potential effect of the adjustment on the learner and others, and the costs and benefits of making the adjustment.

Reasonable adjustments need only be that – reasonable. It is about identifying what adjustments might reasonably be made and how they may be put into place.

Assessment processes and techniques should be modified for distance-based learners, be culturally appropriate and suitable to the communication skill level, language, literacy and numeracy (LLN) capacity of the candidate and the work being performed.

An individual's access to the assessment process should not be adversely affected by restrictions placed on the location or context of assessment.

FSK Foundation Skills Training Package

The FSK Foundation Skills Training Package allows RTOs to choose and deliver foundation skills Units of Competency, qualifications and Skill Sets that will enable learners to build the specific foundation skills they need to achieve vocational competency.

Foundation skills Units of Competency provide additional information about the types of language, literacy and numeracy skills that are needed to meet the requirements of vocational Units of Competency.

Health and safety implications in the industry

Work health and safety (WHS)/occupational health and safety (OHS) has been used in Units of Competency to refer to the relevant legislation. As not all jurisdictions have implemented the Model Work Health and Safety (WHS) Act the combined term is used to recognise that either the national model or existing state/territory instrument will apply, as specified by the relevant regulatory authority.

In jurisdictions where the Model WHS Act has not been implemented, RTOs are advised to contextualise the Unit of Competency by referring to the existing state/territory OHS legislative requirements.

Resources and equipment relevant to the Training Package

The assessment requirements relevant to each Unit of Competency refer to the relevant resources and equipment required for assessment.

Where a specific vehicle or piece of equipment is referred to, it must be used in the relevant assessment.

In particular, for assessment, access is required to:

- a range of relevant exercises, case studies and/or simulations
- a vehicle typical of that used in the industry
- applicable documentation, including workplace procedures, regulations, codes of practice and operation manuals
- relevant materials, tools, equipment and personal protective equipment (PPE) currently used in industry.

Specific assessment requirements and strategies are defined in the relevant Unit of Competency where applicable.

RTOs can only conduct training and/or assessment of the qualifications and/or Units of Competency in this Training Package provided they are covered by their Scope of Registration.

The assessment requirements for each Unit of Competency specify the relevant resources and equipment required to achieve the vocational outcomes of the AVI Aviation Training Package.

Legal considerations for learners in the workplace / on placements

Legal requirements that apply to specific industries and VET vary across each state and territory, and the Commonwealth, and can change.

Figure 1: Foundation Skills Model

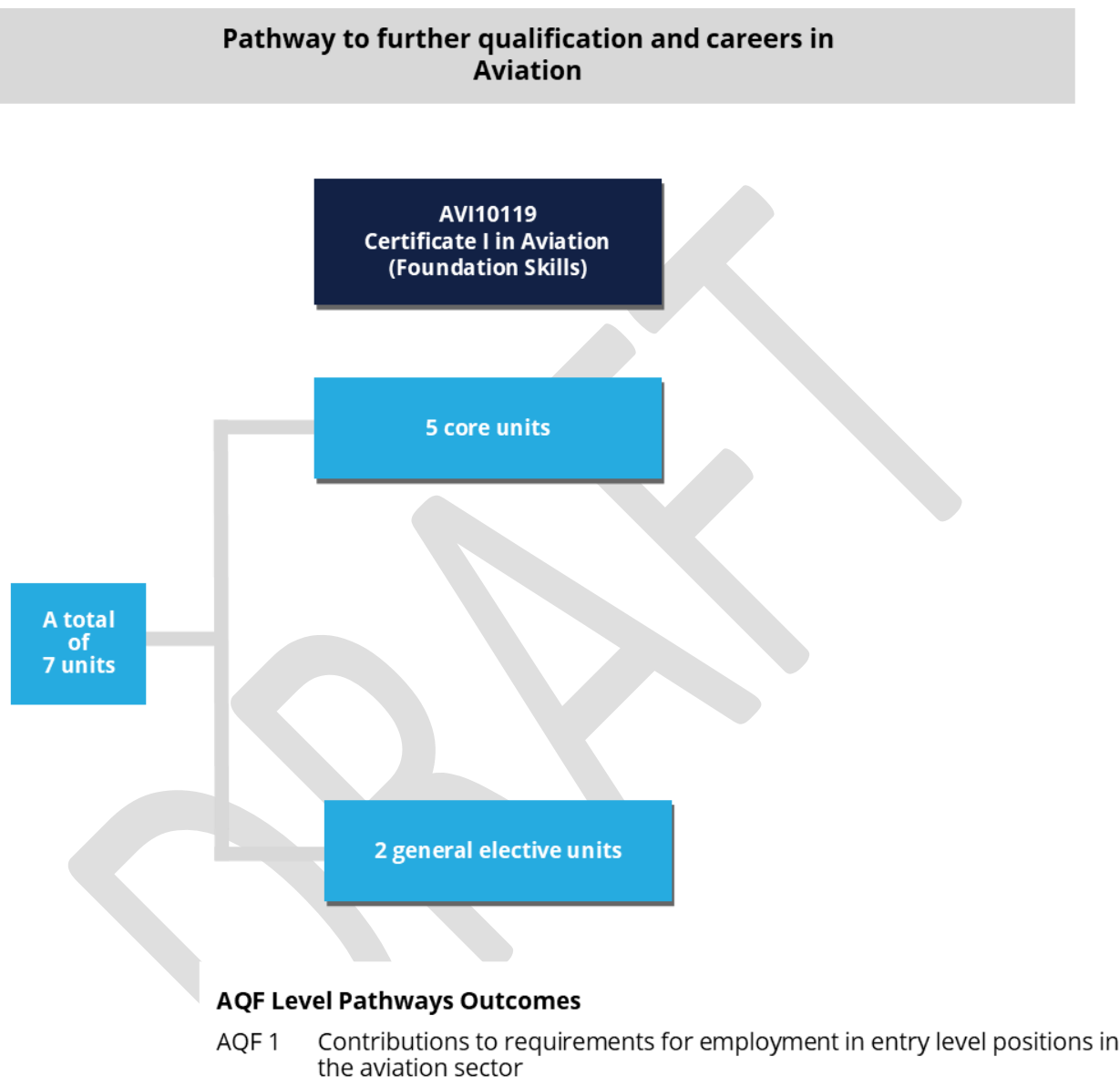
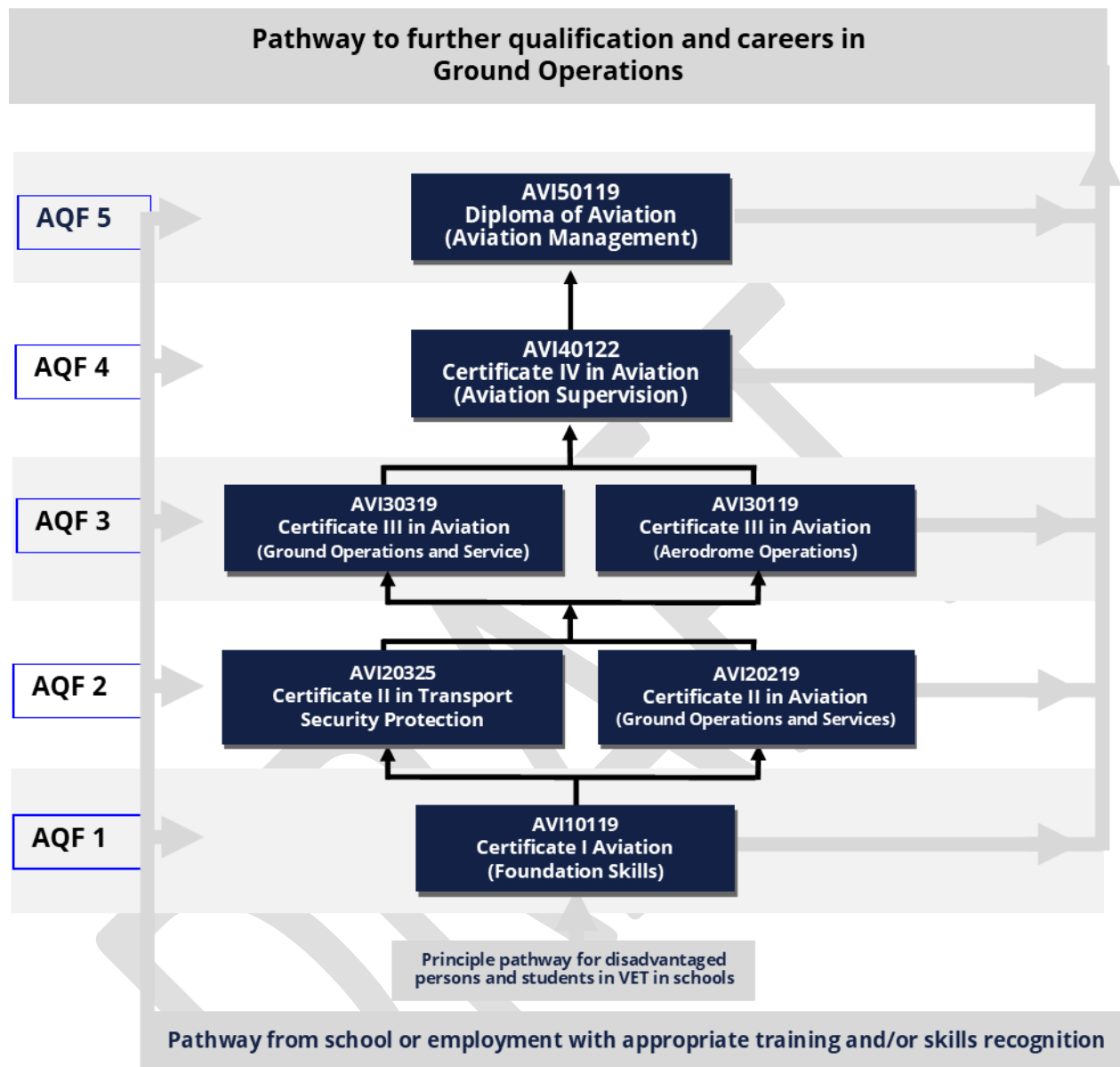
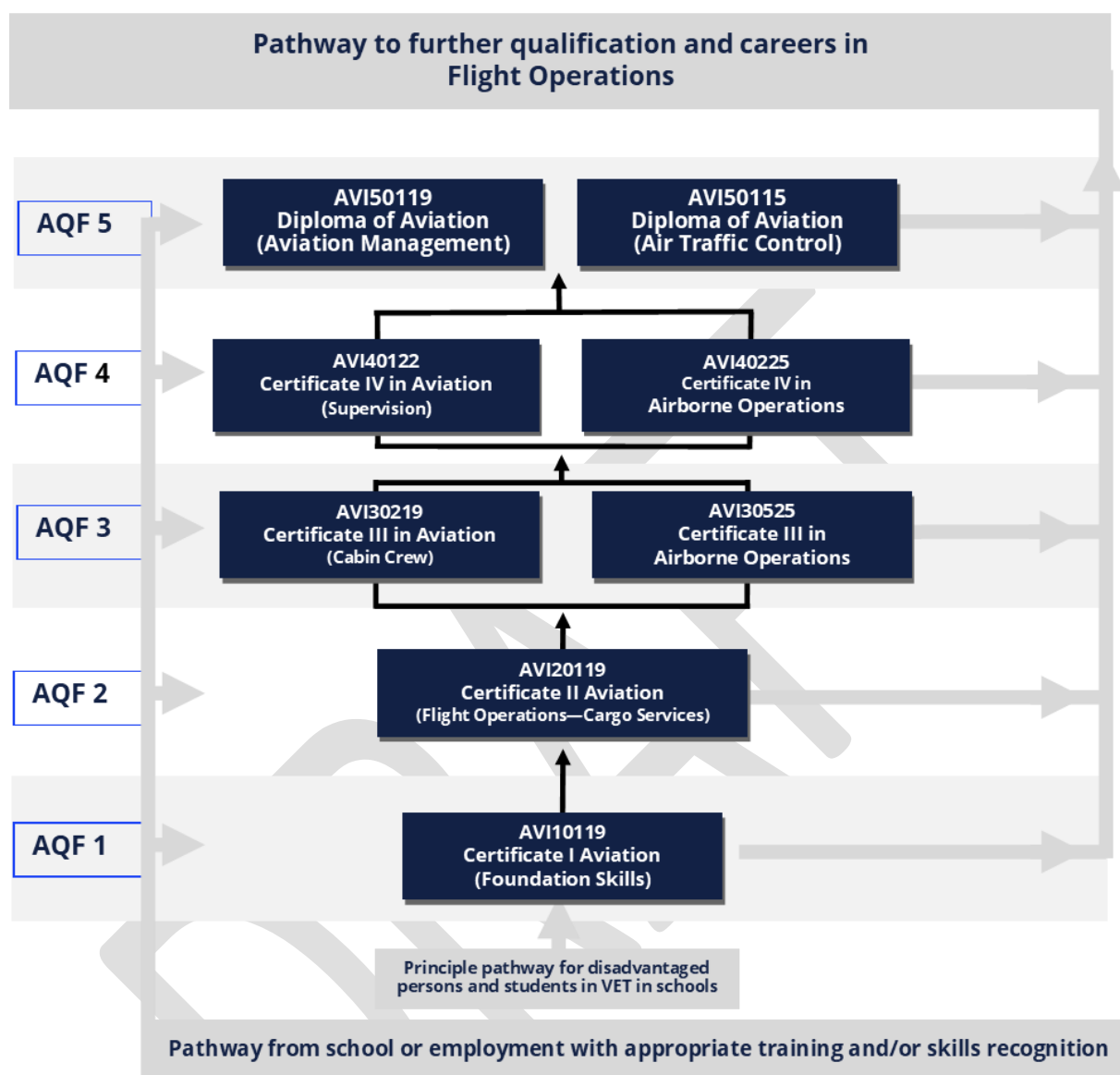
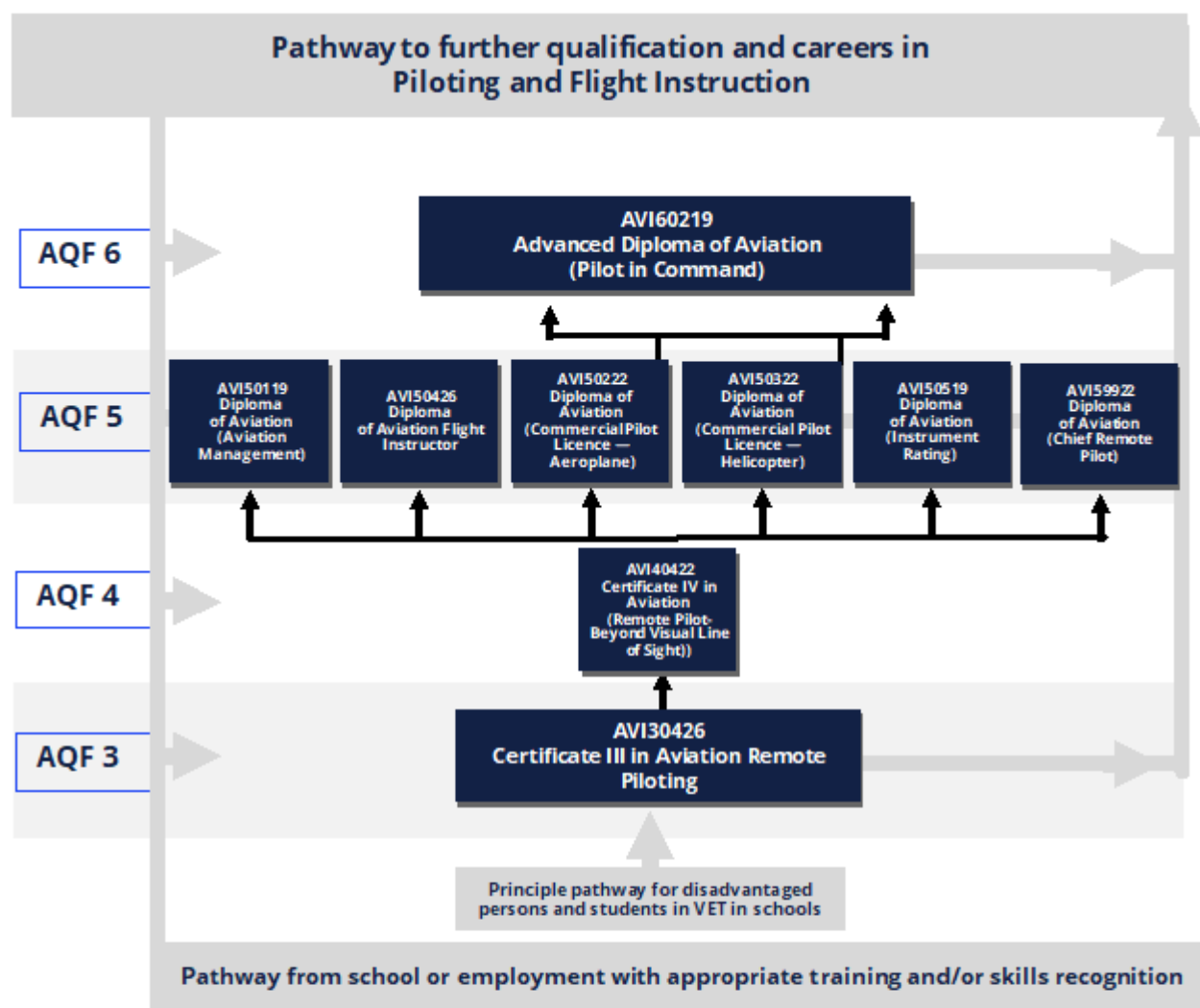


Figure 2: Aviation Management

ATTACHMENT E: Qualification Purpose

AVI30426 Certificate III in Aviation Remote Piloting

This qualification is designed to provide students who aspire to become drone operators with the skills and knowledge required to undertake the Civil Aviation Safety Authority (CASA) assessment for the Remote Pilot Licence (RePL). It offers a Vocational Education and Training (VET) pathway that supports students in working towards the attainment of the RePL licence.

The qualification is underpinned by a standardised curriculum that aligns with both educational and regulatory requirements, ensuring that students are well prepared to meet CASA licensing standards and assessment outcomes.

AVI50426 Diploma of Aviation Flight Instructor

This qualification is designed for Pilot Instructors to train pilots to become instructors for beginner pilots. This qualification maps directly to the CASA Regulation - Principles and Methods of Instruction (PMI) to ensure potential Flight Instructors receive all the relevant training to enable the trainee pilots to satisfy CASA requirements of Regulation Part 61.

ATTACHMENT F: Implementation Advice

AVI20325 Certificate II in Transport Security Protection	
In addition to completing the Certificate II in Transport Security Protection qualification, all screeners and examination officers must pass annual accreditation tests in all screening and examination functions and powers they perform. Performing stall recovery may include:	- minimising height loss for simulated low altitude condition - positively reduce angle of attack - re-establishing desired flight path, and controlled and balanced operation of the RPA - using power available and available height to maximise the aircraft energy state
Recovery from manoeuvres may include:	- incipient stall - stall when climbing, when descending, during an approach to land configuration and when turning - stall with full power applied - stall without power
Repositioning for landing may include:	- making allowance for wind velocity during go-around - manoeuvring the RPA clear of the ground and conducting after launch procedures - selecting power, attitude and configuration to safely control the RPA
Taxiing on ground or water may include:	- applying correct handling techniques to take wind into account - avoiding causing a hazard to another aircraft, objects or persons

ATTACHMENT G: CVIG – Quality Assurance Process

Quality Assurance Process

A CVIG is initiated in accordance with the requirements of the Standards for Training Packages.

The steps in the Quality Assurance (QA) process as they apply to the CVIG are:

1. The CVIG is developed by ISA in accordance with Standards 11 and 12:
 - **Standard 11:** A quality assured CVIG produced by the Training Package developer is available at the time of endorsement and complies with the CVIG template
 - **Standard 12:** Training Package developers produce other quality assured companion volumes to meet the needs of their stakeholders as required
2. The Implementation Guide is designed to assist assessors, trainers, training providers and enterprises to deliver nationally endorsed industry training packages.
3. Content is validated and amended as part of the validation stage in the implementation of the Standards.
4. The CVIG is submitted for QA with the Training Package changes, to ensure it is available at the time of endorsement.
5. The CVIG is reviewed by ISA to ensure mapping tables are updated and any additional information is added as required. Proposed changes are subject to industry validation as part of the endorsement process.
6. Where changes are made to a Training Package and minor amendments are required for the CVIG, ISA includes amendments as part of the validation phase and incorporates the reference in the version control modification history at the front of the CVIG.
